Content:

Plan and prepare for light vehicle operation

- Access, interpret and apply light vehicle
- operations documentation and ensure the work activity is compliant
- Obtain, read, interpret and clarify vehicle information, work requirements and travel details
- Plan vehicle operation considering work activity, travel duration, passengers and equipment safety
- Select and load equipment and/or ancillary attachments
- Identify, address and report potential hazards and risks
- Select and wear appropriate personal protective equipment for planned work activities

Operate light vehicle

- Carry out pre-start, start-up, park-up and shutdown procedures
- Operate light vehicle
- Operate equipment within recommended speed, engine capability and limitations
- Use vehicle lights and indicators in accordance with traffic regulations
- Identify and respond appropriately to hazardous and/or emergency driving situations
- Complete light vehicle operations according to work plan
- Identify, address and report environmental issues

Carry out operator maintenance

- Conduct visual inspections to identify faults
- Conduct routine operational servicing and housekeeping activities
- Carry out minor maintenance and repairs
- Report defective or irregular performance
- Maintain and update vehicle written records
